A Public Hearing will be held on Tuesday September 15, 2026 at 9:45 am. All Public Hearings are open to the public and attendance, either in person or virtually, is encouraged. Written and verbal submissions may be made at the Public Hearing.

Purpose of the Public Hearing: The Council of the County of Wetaskiwin No.10 is considering Bylaw 2026/03, a bylaw to amend the County's Municipal Development Plan (Bylaw 2023/05).

The proposed amendments are intended to refine the Municipal Development Plan based on more than three years of implementation experience while maintaining Council's existing planning vision and policy direction. The amendments are intended to improve the clarity, consistency and day-to-day implementation of the Plan.

The proposed amendments generally include:

- updating terminology, definitions and formatting throughout the document;
- clarifying agricultural and subdivision policies, including agricultural capability and fragmentation;
- refining recreation, infrastructure and servicing policies;
- improving alignment with the County's Land Use Bylaw, Area Structure Plan Policy and other statutory planning documents; and
- removing redundant or outdated policies where matters are already addressed through other legislation, policies or municipal processes.

The proposed amendments apply County wide and do not relate to a specific parcel of land or development proposal.

- Persons claiming to be affected may attend, without prior notification, to make their views known by presenting or speaking at the Public Hearing.
- Please note that the Council Meeting will be in progress, beginning at 9:00 a.m., and members of the public are asked to enter and be seated in the gallery with minimal disruption.
- Written submissions will form part of the Public Hearing record and will be presented at the Hearing.
- Submissions must relate to the proposed Municipal Development Plan amendments.
