Payment may be submitted via mailed cheque or cash, you can use the same method as you pay taxes or utilities through your online banking (just use 999901 as the account number), or you can pay online via credit card. There you can enter your card info and payment info (\$50.00 total for the development permit. The type of payment will be 'Sign Permit' and the description being billing code 'PD01'.)
