FINANCE-CENTRAL MANAGEMENT - CONTRACTED & GENERAL SERVICES - Budget 2021

Budget reduced due to results from 2020 RFP.

FINANCE-CENTRAL MANAGEMENT - DEBENTURES & BANK CHARGES - Budget 2021

Debenture payments have been reduced as the Correction Line Debenture has been paid in full.

FINANCE-CENTRAL MANAGEMENT - TAXATION - Budget 2021

Increased due to Viola, Village and the car wash being charged.

FINANCE-CENTRAL MANAGEMENT - OTHER REVENUE - Budget 2021

2020 Tax penalty actuals are down due to the pandemic. Council voted to waive the September 1, 2020 6% penalty.

Due to the global pandemic, interest rates have plunged to .60% from 2.20%. C10 general account earns interest at the same rate as a high interest savings account. Given the economic outlook and possible cash flow issues from unpaid taxes, liquidity has been the main focus for County funds.
