Re: Notice of Annexation Application Hearing – Summer Village of Poplar Bay

The Land and Property Rights Tribunal (Tribunal) will conduct a public hearing respecting an application by the Summer Village of Poplar Bay (SV) to annex territory from the County of Wetaskiwin No. 10 (County). The hearing is scheduled as follows:

DATE: Friday, June 23, 2023
TIME: 10:00 AM
LOCATION: **This hearing will be conducted via WebEx**

The proposed annexation area involves approximately 2.2 hectares (5.4 acres) of land. The application states that the proposed annexation will provide the SV with land for residential development.

Although the two municipalities have negotiated an agreement, objections to the proposed annexation require the Tribunal to conduct a public hearing. The public hearing process will allow the Tribunal to receive information and evidence from interested parties about this matter. After considering the submissions from all parties, the Tribunal will make an annexation recommendation to the Minister of Municipal Affairs.

If you wish to participate in the hearing and/or want to make an oral submission to the Tribunal during the proceedings, please register with the Tribunal office by 12:00 noon on Thursday, June 15, 2023. Written submissions pertaining to the hearing should be received by the Tribunal no later than 12:00 noon on Thursday, June 15, 2023. Copies of all written submissions received by the Tribunal will be forwarded to the SV and the County prior to the hearing and may be made available to the public .
